

MINUTES OF THE REGULAR SESSION OF THE LINN COUNTY BOARD OF COMMISSIONERS LINN COUNTY COURTHOUSE – ROOM 200 APRIL 25, 2023

The Linn County Board of Commissioners met for the regularly scheduled meeting on Tuesday, April 25, 2023.

- 1, 2, 3. At 9:30 a.m. Chair Nyquist called the meeting to order. The flag salute and roll call followed. Commissioners Roger Nyquist, Chair; Will Tucker, Vice-Chair and Commissioner Sherrie Sprenger were present, as well as, Darrin Lane, Linn County Administrative Officer and Marsha Meyer, Recorder for the Board of Commissioners.
- 4. Approval of Agenda.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve the agenda. The vote was called. The motion passed unanimously.

5. Approval of the April 18, 2023 Commissioners' Meeting Minutes.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve the April 18, 2023 Commissioners' Meeting Minutes. The vote was called. The motion passed unanimously.

6. Sheriff's Office - Michelle Duncan, Linn County Sheriff.

Eric Slinger, Lieutenant Corrections Division, Linn County Sheriff's Office, presented the following item:

A. Order 2023-161 establishing the maximum allowable number of inmates and standards for determining County jail population emergency and adopting a plan for resolving such emergency.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Order 2023-161. The vote was called. The motion passed unanimously.

Rick Lentz, Emergency Manager, Linn County Sheriff's Office, presented the following items:

B. Resolution & Order 2023-165 approving a Grant Agreement No. SP22-047 between the State of Oregon Department of Emergency Management State Preparedness and Incident Response Grant Program and Linn County and delegating authority to execute originals.

C. Resolution & Order 2023-166 approving a Grant Agreement No. SP22-041 between the State of Oregon Department of Emergency Management State Preparedness and Incident Response Grant Program and Linn County and delegating authority to execute originals.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution & Orders 2023-165 and 166. The vote was called. The motion passed unanimously.

Commissioner Nyquist called Sheriff Duncan to the podium. He indicated that an individual, Tim Walters, had contacted him about the maintenance of the Miller Cemetery in Millersburg. Commissioner Nyquist stated that Mr. Walters had a plan, however, he thought it may be problematic and would involve competing businesses. Commissioner Nyquist, instead, asked Sheriff Duncan if her office, using the work crews, could do some level of maintenance on the County's cemeteries to solve this challenge. Sheriff Duncan stated that work crew numbers had been down so she did not want to take on more than what she could commit too. Discussion followed.

Commissioner Nyquist asked Sheriff Duncan to look into this matter. She then gave her business card to Mr. Walters so they could further discuss this matter.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution 2023-150. The vote was called. The motion passed unanimously.

D. Resolution & Order 2023-155 reinstating the Linn County Weed Control Committee and renaming the Weed Control Committee to the Noxious Weed Control Advisory Committee.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution & Order 2023-155. The vote was called. The motion passed unanimously.
