R&O 2023-177

This is an Intergovernmental Agreement between Linn County and Lincoln County for to establish a Nurse Family Partnership Incentive Fund Grant program. This agreement has a not to exceed amount of \$350,000.00 and will terminate on February 28, 2026. This agreement is to provide nurse home visiting to vulnerable moms with care and support to have health pregnancies and to achieve better lives for themselves.

Order 2023-203
