This Resolution and Order is a Temporary Part-Time Employment Agreement with Savanna Rucker. Savanna will be resigning from her full-time position as a Medication Aide at the end of September 2023. STIF Discretionary Funds Summary:

STIF Discretionary Funds are Statewide competitive funds where ODOT selects project proposals submitted from all over Oregon. Many Public Transportation Providers possess qualifications that allow them to independently submit application on their own behalf. Senior Citizens of Sweet Home, Inc./Linn Shuttle requires the assistance of a qualifying entity to access these funds which is a standard function of the Linn County Transportation Program.

Linn County worked with Senior Citizens of Sweet Home, Inc. to submit a project proposal for acquisition of a new vehicle. Much of the fleet at Linn Shuttle is nearing the end of its useful life and the program has been soliciting funds from many different resources to lower the average age of their fleet.

ODOT selected the Linn County/Senior Citizens of Sweet Home Inc. project for funding in the 2023-2025 biennium. The STIF Discretionary Grant Agreement 35593 is not to exceed \$140,000.00. Upon entering into agreement 35593, Linn County will establish a sub-recipient agreement with Senior Citizens of Sweet Home, Inc., monitor that the use of funds align with the approved project objectives, and provide status/outcome reports to ODOT.

Benton: 5 youth were held for 80 total of days of care, 0 females and 5 males.

Linn: 17 youth were held for 238 total of days of care, 4 females and 13 males.

Total Admissions to Detention = 18 Average Daily Population = 7.68 youth Average Length of Stay = 13.22 days

Lincoln 5 youth were held for 54 total days of care, 2 females and 3 males

Total Admissions to Detention = 6 Average Daily Population = 1.74 youth Average Length of Stay = 9.00 days

Time for Change Program: 0

Probation

The Juvenile Department received 46 referrals during the month of August 2023.

Of the 46 referrals, 6 represent dependency, 12 status and 17 criminal.

There are currently 189 youth in the Probation Unit either on probation or pending court with 35 of those being assessed high-risk.

There are currently 82 youth under the Community Programs Unit serving on informal probation and the Intervention Specialist is currently serving 30 youth. 25 of those youth are from the community with no involvement with law enforcement.

Community Wildfire Reduction Program - 1 youth complete 8.75 hours in 1 project day







Resolution and Order 2023-322 Personal Services Contract between Grace Wellness and Linn County Not to exceed \$100,000 over two years

RO 2023-322 is a contract with Grace Wellness which is the Social Workers the Department has been contracting with for the last three years. These licensed Social Workers are receiving direct referrals for service from the department and are seeing 4 to 6 youth at any given time. As they have established themselves within the department probation officers are seeing the opportunity to connect youth on their caseloads with a social worker who not only works with the youth but also with the parents of the youth referred. Access to mental health services is very difficult for youth and families because of the growing need. The two social workers also happen to be bilingual and bi-cultural Spanish which has addressed a big deficit in services for our Latino families and youth. The funding for this contract comes from our Basic Service dollars received from the Oregon Youth Authority contract.

The following item is scheduled to be signed by the Board on September 26, 2023:

Resolution & Order No. 2023-352 – PLN-2022-00729; combined applications submitted by Casey Meadows for two property line adjustments between three properties. The properties are located at41659 Rodgers Mountain Loop, approximately 0.19 miles west of the intersection of Rodgers Mountain Loop and Sledge Road, and approximately 4.56 miles southeast of the city of Scio (T10S, R01W, Section 24, Tax Lots 200, 204, and 205).

On March 2, 2023, the Linn County Planning Director issued a land use decision approving PLN-2022-00729, combined applications for two property line adjustments for property located at 41659 Rodgers Mountain Loop, approximately 4.56 miles southeast of the city of Scio. On March 16, 2023, a party with standing appealed the Planning Director decision to the Linn County Planning Commission (Commission).

On May 9, 2023 and June 13, 2023, the Commission conducted *de novo* public hearings to review the applications on appeal. After considering the applications, the evidence in the record, and the testimony provided at the hearing, the Commission voted 3-2 to approve the applications. The Commission decision was issued on July 7, 2023. On July 21, 2023, a party with standing appealed the Commission decision to the Board.

The 150-day time limit in Oregon Revised Statute (ORS) 215.427, within which the County is required to take final action on this application, expired on February 24, 2023. As of the date of this memo, the applications are over the time limit for the County to make a final land use decision on this application. Because the time limit has been exceeded, the number of days remaining to comply with ORS 215.427 is not sufficient to comply with public notice and hearing requirements in both state law and County Code.

Linn County Code (LCC) 921.220(C) provides: "Notwithstanding any provisions in this Code to the contrary, if a time limitation is about to expire and a final decision has not been made, or if the Commission has made a decision and a time limit is about to expire, the Board may enter an order affirming the findings and conclusions of the Commission without conducting any further hearings." This provision is also in place to allow for the affirmation of a decision if a time limit has expired.
