Full-time position working in the Engineering Division of the Linn County Road Department

ESSENTIAL FUNCTIONS OF THE JOB: Perform the following essential functions and related duties:

- Perform professional engineering work in the planning, design, construction, and maintenance
 of public works and related projects; such as road and bridge design and construction, traffic
 design, drainage facilities or related work
- Preparation and review of project plans, specifications, cost estimates and contract documents for public works projects
- Prepare progress reports, field notes, engineering studies and maintain records
- Coordinate assigned activities with consultants, engineers, contractors and other outside agencies
- Review contractor submittals and coordinate contract conflicts or changes
- Plan and perform field inspections
- Review and evaluate project compliance with project plan, specifications, and applicable local, state and federal laws and regulations
- Assist with right-of-way duties, including cooperation and coordination with utilities
- Other duties as assigned

QUALIFICATIONS:

- Bachelor of Science in Civil Engineering from an ABET-accredited university
- Registration with the State of Oregon as a Professional Engineer
- Minimum (3) years of experience with Civil Engineering principles and methods, with an emphasis in roadway or bridge design
- Proficient in Autodesk AutoCAD, with preferred experience with Autodesk Civil 3D
- Proficient using Windows operating systems and Microsoft Office (Excel, PowerPoint, Word, Outlook)
