

TAC Meeting Minutes 12/15/2022

*Adopt meeting minutes – Marilyn moves 12/05 minutes be approved as amended. No second. No objections were made of the preparation of minutes. Minutes adoption tabled for next meeting.

*Public commenters- Lisa Scherf of City of Corvallis QE Benton County- Several projects are shared between Linn and Benton County, expressed shared interest regarding services to Benton County; Benton County is in review of STIF projects.

Dawn Mitchell- Senior Citizens of Sweet Home Inc. non-profit director, applications present for TAC consideration. Ted Frazier- represents beneficiary of Albany applications present, Marilyn Smith- City of Albany council, shared interest in Albany transportation projects.

*5310 Applications and TAC recommendations to BOC-

* **5310 Small Urban \$318,600-** City of Albany sole applicant in the amount of \$318,600. Prior year award \$210,000. Funds are used for paratransit and Call-A-Ride, senior and disabled transportation.

Kindra moves to recommend City of Albany \$318,600 per application, JoAnn seconds. TAC votes all in favor with Ted Frazier abstaining. Motion Passes.

Reagan tasked with making a legal service request for Linn County legal department review and feedback.

Dispute resolution policy was reviewed.

Ken calls for an emergency meeting to be held on December 22nd at 1:00 PM to discuss the STIF Plan and Letter of Protest.
